Dear XCAP committee members,

I am writing to state that my husband and I are OPPOSED to the underpass design for grade separation at Charleston Road. We oppose this design for the following reasons:

- -Creates a HUGE TWO LANE ROUNDABOUT on a quiet two lane residential street.
- -Uses eminent domain to take MANY private properties from Palo Alto residents for the construction of the 2 lane roundabout complex as well as seizing further property for the pedestrian/bicycle underpass lanes.
- -Destroys the Charleston/Arastradero calming corridor project that was implemented to decrease the amount and speed of traffic on this corridor. It's purpose was to make this a safe walkable/bikeable community street because it has multiple schools, churches, parks and residential homes.
- -This design forces MUCH MORE traffic onto East Charleston because all north bound Alma traffic that normally turned left onto West Charleston will now need to turn right onto East Charleston and drive down to the roundabout to turn back east.
- -This design is not necessary as there are other grade separation alternatives that will not destroy this street/corridor that has multiple schools, churches, parks and homes.
- -Palo Alto residents worked for over 10 years to get the Charleston/Arastradero calming project implemented on East Charleston and this design would not only reverse all of the calming but would actually make it worse than before the project was implemented.

Please DO NOT recommend the underpass grade separation design at Charleston Rd.
